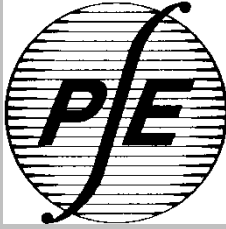
President's Message – Todd (T.J.) Yerdon, PE

Review of the 54th Annual Conference: Impressive – Shannon Schultz, PE, CFM

Abraham Lincoln said, “Give me six hours to chop down a tree and I will spend the first four sharpening the axe.” ...meaning, good planning pays off. And that is just what happened this year in Sioux Falls. The Eastern Chapter slayed the 54th Annual Conference. Thanks to a talented line up of speakers, generous sponsors, and dedicated planning committee members, the Conference was a huge success.

According to Todd Yerdon, SDES State President, “We had excellent attendance. The venue was top notch [Holiday Inn City Centre]. Good food and meals. The tour was interesting. And there was a wide variety of good speakers and topics. I am very proud of what the Eastern Chapter did this year at the conference.”

As far as numbers go, there were 210 registrants including vendors and speakers. Total revenue will come in around \$31,100 with total expenses of \$17,600 (\$15,520 of which is the food and hotel bill). Deducting the \$7,000 owed to State, that leaves around \$6,400 for the Eastern Chapter.

Regarding submitted feedback, it was overwhelmingly positive. Attendees offered the following general comments:

SOUTH DAKOTA ENGINEERING SOCIETY 2013 STATE AWARDS

The South Dakota Engineering Society annual presentation of awards to honor the engineers and projects in South Dakota was held on Thursday, April 17, 2014, at the Holiday Inn City Centre, Sioux Falls, SD during the SDES 54th Annual Conference.

YOUNG ENGINEER OF THE YEAR WESTON PHILIPS, PE, SIOUX FALLS, SD

This award is established to recognize young SDES members who have made outstanding contributions to the engineering profession and their communities during the early years of their careers.

Weston Philips, PE, was honored as the South Dakota Engineering Society's 2013 Young Engineer of the Year.

Mr. Philips is the Principal Street Engineer for the City of Sioux Falls. As the Principal Street Engineer, Wes helps manage the City's street maintenance program, which in 2014 will total over \$8.97 million. Wes also provides design overview and guidance for all street projects within the City of Sioux Falls. Mr. Philips has been an active member in the SDES Eastern Chapter since 2006. Wes has served on the Scholarship Committee, Awards Committee, assisted with Mathcounts, and made presentations at the Eastern Chapter meetings. Wes holds a bachelor's in civil engineering from Iowa State University and a master's in engineering from South Dakota State University.

This award is established to recognize SDES members who have made outstanding contributions to the engineering profession, the public welfare, and/or humankind.

Albert Berreth, PE, was honored as the South Dakota Engineering Society's 2013 Engineer of the Year.

Al retired from the Indian Health Services after serving the majority of his career with the IHS. He retired from IHS in 2010 as the District Engineer. At the time of his retirement the Pierre District was working on projects that included a \$1.5 million waterline extension north of Pine Ridge Village, a new water treatment plant on the Crow Creek Indian Reservation, a new lift station for the Kyle Community, technical assistance and a water treatment plant and system for the Tri-County water system, and the design and development of water and sewer services to roughly 150-200 individuals on the four Indian Reservations.

Al holds a bachelor's and a master's in civil engineering, both earned from the South Dakota School of Mines and Technology. He has been a member of NSPE/SDES since 2001.

OUTSTANDING ENGINEERING ACHIEVEMENT AWARD HDR Engineering and Minnehaha County Highway Department Baltic Bridge Replacement, Baltic, SD

This award is established to acknowledge the accomplishments of the engineering profession. Each year SDES recognizes engineering achievements that have captured the innovative and dynamic spirit of a profession dedicated to public service.

The Minnehaha County Baltic Bridge Replacement project encompassed the needs of a full service civil engineering team, with experience and the dedication to meet a very important challenge. In mid-September 2012, the Baltic Bridge on County Highway 114 just west of Baltic, spanning the Big Sioux River, was closed immediately while completing the bi-annual bridge inspection. The structural engineers found significant section loss in several locations of the steel girders and noted that the deck was in extremely poor condition. Understanding that this bridge was only a few hundred feet from the local elevator and heavy loads pass over this bridge daily, the decision was made to permanently close the structure until it could be replaced. HDR was immediately contacted by the Minnehaha County Highway Department and briefed on the condition and decision to close. Within one week, HDR and County officials held the first public meeting to provide answers to the Baltic citizens, businesses owners along County Highway 114 through Baltic, city officials, and concerned county residents. Many concerns were raised as to why this happened and what was being done to re-open the Bridge to traffic. As engineers, we are trusted professionals that apply very important principles to the work that we do. Our city and county residents trust that we make the very best decisions possible, based on the information we have. HDR and Minnehaha County officials developed options for the bridge reconstruction, selected an option providing a long term solution, completed the design, and prepared for construction beginning in March, 2013.

On September 11, 2012, structural deficiencies required the closure of Baltic Bridge, outside of Baltic, SD. Due in large part to the problem solving skills and team dedication, the design and construction process was completed in ten months, with the ribbon cutting for reopening the bridge on July 16, 2013.

President Adam called the meeting to order at 3:00 p.m. Gundvaldson confirmed a quorum for the meeting.

The IRS is now inquiring whether non-profit tax-exempt entities have adopted a Conflict of Interest Policy to ensure that charitable funds are not being used for anyone's private gain. Hearing no conflicts from the board members in attendance, Adam proceeded with the meeting.

Review and Approval of Meeting Agenda

Adam made the following modifications to the agenda:

Roads are Vital Initiative – Added

Treasurer's Report and 2014-2015 budget discussion – Moved to the end of agenda

Froelich made a motion to approve the amended agenda, Gundvaldson seconded the motion and the motion carried.

Minutes of Previous Board Meeting

Yerdon made a motion to approve the January 31, 2014, board minutes, Froelich seconded the motion and the motion passed.

President's Report - President Myron Adam, PE/LS

Adam thanked everyone for their support in his tenure as 2013-2014 SDES president. His written report discusses Mathcounts and the Design Professionals Coalition – both of which will be discussed later in the meeting. No action.

President-Elect's Report - President-Elect TJ Yerdon, PE

No report.

Vice President's Report – Vice President Stacy Froelich, PE

No report.

Welcome to 2014 SDES Annual Conference

Shannon Schultz, co-chair of the 2014 annual conference, thanked everyone for attending and supporting the conference. Schultz reported that approximately 200 attendees have registered for the conference.

Goal 1: Promote the competent, ethical, and professional practice of engineering.

Membership – Gail Boddicker, Executive Director

Boddicker reported that SDES membership is at 467 members; an increase of 3 members since the January 2014 report.

Goal 2: Enhance the image and stature of engineering professionals.

University and Public Relations

Hanisch met with SDSU ASCE students to provide an overview of the societies. Hanisch distributed new member applications and returned with 18 new student members.

Phil Gundvaldson noted the Career and Technical Education (CTE) Academy approached SDES about having one of our members sit on their advisory board. Ryan Johnson volunteered for this effort. The CTE academy partners with area high schools to provide introductory courses for careers in STEM related fields. CTE will look for advisory board members from SDES next year.

Goal 3: Provide education, professional development, networking opportunities, and other benefits to engineering professionals and students.

Awards – Laurie Schultz, PE

Schultz will present the Engineer of the Year, Young Engineer of the Year and the Outstanding Project of the Year at the SDES 54th Annual Conference luncheon on Thursday, April 17, 2014. Schultz will step down as the Award Chair after this year.

Endowment Promotion

Kjenstad reported that the net assets are at \$30,530.00 with \$2,400 available for distribution. Yerdon made a motion to provide \$800 to the BH, CE and Eastern Chapters for scholarships, the motion was seconded and was approved. **The Foundation requires information on the scholarship recipient and Boddicker was tasked with distributing the policy to the chapter scholarship chairs.**

MATHCOUNTS – Shannon Schultz, PE

Schultz reported that the Mathcounts state competition was successful with very competitive students. Students from Bath, SD, the Eastern Chapter and the Black Hills Chapter will be competing at the May 8-11, 2014 Raytheon MATHCOUNTS National Competition in Orlando, FL.

Schultz reported that there will be a need for the chapters to help defray expenses associated with the state competition. The final income from MC has not yet been received; therefore, it is not clear the amount of funds that will be needed to help with the state competition deficit. It was decided that the Eastern Chapter will assume 50% of the deficit and the BH and CE Chapters will assume 25% respectively.

The board discussed possible methods of decreasing expenses. **Morris will contact the Kings Inn in Pierre to investigate means of decreasing the expenses at the hotel.**

There was also discussion that the CE Chapter may discontinue the Chapter Mathcounts competition as they have seen a decrease in school participation each year. This year there were only two schools competing. They plan to discuss and to make a decision at their May 2014 meeting.

Goal 4: Advocate the interests of engineering professionals and protect the public through an effective government relations program.

Design Professionals Coalition – Al Berreth, PE, Jeff Hines, PE

The board is questioning whether SDES should continue its affiliation with DPC. **Following discussion, it was**

decided that Yerdon will meet with the presidents of the remaining DPC entities and Justin Bell, the liaison, to gather additional information. This issue is tabled to the summer meeting.

Licensure – Brian Jenner, PE

Jenner reported that the FE is now offered as a computer-based exam. Currently, there is no test site in Rapid City; therefore, examinees must travel to Sioux Falls or Casper for the exam. The board is looking at new facilities for the board office. Mike Albertson has replaced Hani Shafai and Steve Peters replaced Randy Bacon on the SD BTP board.

SD Local Transportation Assistance Program – Jason Kjenstad, PE

Kjenstad is the SDES representative on the LTAP committee and attended a recent meeting. Kjenstad reported that there is online training available from LTAP. No action taken.

Goal 5: Align the structure, activities, and governance of the society to optimize support and resources for all programs.

Strategic Planning Task Force

No report.

Nominations – Jody Page, PE

At the January meeting, the vice president position was vacant; however, Brian Jenner has now volunteered for the vice president position. Froelich made a motion to approve Brian Jenner as Vice President, Phil Gundvaldson seconded, and the motion passed.

Chapter Activity Reports

Black Hills Chapter

Jenner reported that the chapter had their monthly meetings and plans are beginning for the 2014 Fall PDH Conference, which will be held in Rapid City.

Central Chapter

Bruels reported that the members will volunteer for the annual ditch clean-up activity. The chapter members are beginning planning for the 2015 annual conference which will be held April 8-10, 2015, in Pierre.

Eastern Chapter

P. Gundvaldson reported that the chapter has continued with their monthly chapter meetings, the past quarter was busy with the E Week activities and the annual conference planning.

Old Business

National/State Agreement

NSPE created the National/State Agreement that clarifies the duties and responsibilities regarding membership, bylaws, intellectual property, dues, insurance and other operational issues within NSPE and the state societies. Yerdon made a motion to sign the Agreement, P. Gundvaldson seconded the motion, and the motion carried. Mark Golden, NSPE Executive Director, will request Art Schwartz, NSPE Counsel, to review the Agreement and cause both parties to sign the Agreement.

NSPE 2014 Annual Conference

The NSPE Annual Conference is scheduled for July 1-6, 2014. The SSEC (executive director's) meeting is scheduled for July 1, the leadership meetings are scheduled for July 2 and 3, July 4 is a free day and the House of Delegates is scheduled for July 5. Ryan Johnson has volunteered as the representative at the House of Delegates on July 5. Boddicker will attend the SSEC and leadership meetings.

Treasurer's Report

P. Gundvaldson distributed the third quarter financial reports and the proposed 2014-2015 budget. Following discussion, Froelich made a motion to accept third quarter financial reports and the revised budget, Bruels seconded the motion and the motion carried. Yerdon, Gundvaldson and Boddicker will discuss developing a monthly financial report to be provided to the board. The board plans to develop a performance review for Boddicker.

New Business

Roads Are Vital Initiative

Toby Crow, AGC Executive Vice President, inquired whether SDES wishes to support the Roads Are Vital initiative. The initiative is focused on finding a solution to the loss of revenue if the Highway Trust Fund goes solvent. The Coalition is proceeding to introduce legislation to increase the gas tax to ensure funds are raised to continue projects in South Dakota. **Crow will be invited to a future SDES board meeting to present on the initiative.**

NSPE Candidate Screening Committee

The North Central Region needs to select a volunteer for the 2015 NSPE Candidate Screening Committee. The screening committee reviews each candidate and determines if he/she is qualified to serve in the position of vice president and the position of treasurer. The position will begin in July 2015 and conclude at the end of April 2016. The list of responsibilities is available upon request.

Mark Golden, NSPE Executive Director and Corporate Secretary

Golden reported that NSPE is focusing on its commitment to making the changes outlined in The Race for Relevance in order to better serve the needs of the licensed, professional engineer at the local, state and national levels. The strategic plan will be voted on at the July House of Delegates.
