

Value Proposition – NSPE Services

NSPE is looking toward the future. Recently we have been attempting to streamline our processes. Adding checks and balances and working hard behind the scenes to come up with a unified member pricing level. That way every NSPE member going from location to location will have the same price point and know and how to access individual member services.

Realizing no state or territory is the same, we believe our best member and partnership experience is served in you, our partners, telling us what you need/want. In our proposed new membership model, we share the work and the expenses based on what, you, the partner, need and want us to provide. We have modeled the services based on membership population, partner staffing, member programs and the volunteer experience level.

Previously, we have asked you, our partners, to perform a “self-assessment” in the form of a scoring rubric to see where needs at all levels of the partnerships exist. From your good work in the evaluation, we are proposing 5 levels of partnership. You the states / territories are free to choose the level of service needed and how the “membership monetary split” will be allocated. It is all about your partnership and experiences. If in the future as each partner grows, their needs may change. Using this model you can revisit your level of service and sharing of dues to best suit your needs, every two years.

Below is a brief description of the NSPE’s business level of service model for state partners depending on their level of need:

- **Full Service:** The full service package provides comprehensive support that elevates the member experience in your state beyond those services you are currently offering, and ensures being a member in your state will be comparable or greater than the member experiences in other states. With NSPE National handling the heavy lifting related to the administrative and communication based services members need to see ROI, YOU have the time and capacity to focus on delivering direct member value at local meetings and events, and building community and engagement with your members
- **Premium Service:** Lessen the variability members may feel in your state/territory versus others by accessing NSPE's premium service package to fill gaps in your current member portfolio
- **Standard Service** Continue to deliver member value, but expand the suite of services you offer by leveraging NSPE national's standard/baseline level marketing, administrative, and program services for only a small share of member dues revenue
- **Basic Service:** Enhance your ability to deliver quality and comprehensive member value by electing the basic service package, and funneling a majority share of member dues directly into your state's programs and services

Al la Carte Service: Services can be provided on an al la carte basis for state/territories not included.
